- (a) As of December 12, 2016, ACICS is no longer recognized by the US Department of Education;
- (b) Although our accreditation is still recognized by the US Department of Education, Camelot College has 18 months following ACICS's loss of recognition to find a new accrediting agency to maintain eligibility to receive funds under Title IV, HEA programs otherwise the Institution would no longer be eligible to receive funds under Title IV, HEA programs;
- (c) The 18 month provisional certification is due to expire June 12, 2018, However, Camelot College has applied for accreditation with the Council on Occupational Education and will be eligible to continue receiving funds under Title IV, HEA programs as long as the final accreditation process is completed prior to the June 12, 2018 date.
